

REGISTRATION OF COPYRIGHT

Registration of Copyright is available under four parts, as under: -

- i) Part-I Literary, Dramatic & Musical Works including Computer Program/Computer Software and compilation of data
- ii) Part-II Artistic Works
- iii) Cinematographic Works including VCD,DVD etc
- iv) Record Works including Audio cassette ,CD

Procedure for Registration

The procedure for registration for all categories of copyrighted works is as under:

- 1- 03 copies of application Form-II in the prescribed pro forma.
- 2- Rs.1000 registration fee in the form of a Demand Draft/Pay-Order in the name of Director General IPO-Pakistan.

A- Artistic Work

- I) 03 copies of Artistic Work.
- II) NOC/ Affidavit for transfer of copyright from Artist/creator who created the work.
- III) Undertaking/ Affidavit for original creativity of the work by the applicant.
- IV) The applicant is required to advertise artistic work in any Urdu or English language daily newspaper, where the applicant resides or carries on business within 30 days of filing of application and send two copies thereof to the Registrar of Copyrights.

B- Literary work

- I) 2 copies of literary work published or un-published (Manuscript)
- II) NOC / assignment of copyright from the Copyright owner/writer of the work in favour of applicant if any.

C- Record & Cinematographic Work

- I) 2 copies of work in the form of VCD/DVD/Audio/Video Cassette etc.
- II) NOC for assignment of copyright from the all contributors (performers/singer/ lyric writer/musician etc.) of the work.
